1. What do you do with my personal data?

4. What data do you hold about me? (And how do you get it?)

We obtain all personal data directly from you. You may have passed your contact details on to us, dropped us your business card, subscribed to our newsletter via our website, or made a booking enquiry or booking with us. Even then, the last part isn't something we're smart enough to do. All personal data that we receive from email or phone correspondence between us is your name, email address, contact number and any other data that you choose to share with us, but yeah - we're not doing anything with that currently.

Our booking widget on our website is controlled by our web operator, Propeller Communications limited. They hang onto the data exclusively for us, and do not have permission to use it themselves.

When making a booking or enquiry via our booking widget on our website, you will be given the option to receive exclusive information and deals, from time to time. We will only contact you with marketing communications if you opt-in to this when using the widget.
